James explained that registration with the Charity Commission required a transition from the previous unincorporated association to a new charitable incorporated organisation. This change and the time it took resulted in no AGM in 2017

The trustees therefore took turns presenting reports on the areas they lead about the past 2 years. All those who had volunteered and helped during the year were also thanked for their efforts.

Finance

The charity's annual accounts for 2016/17 and 2017/18 were presented. A legacy bank account with COOP was closed down and, about £6,000 transferred into our main account. Financial management has been improved by using Quickbooks software and establishing reserve of £3,000.

Charity registration

This was completed with the Charity Commission on 23 January 2018. Our records with HMRC need to be updated in order to claim Gift Aid.

Questions

Members were given the opportunity to ask the Trustees questions about the years under review. No questions were raised.

Elections for trustees

James explained that the rules of the new organisation mean that from now on a third of trustees will now retire by rotation each year. So those elected now could be in post for 1, 2 or 3 years.

James described how for brevity, unless there are objections, the custom is to appoint the nominees en-masse rather than individually. He proposal this and it was seconded from the floor.

The meeting then voted unanimously to appoint the nominees as Trustees.

Governance consultation

James described an idea to reform the membership scheme by limiting it to people who have aniridia or a representative of such people. He also outlined an alternative: changing the organisation from an association to a trust, which does not have members or AGMs. there was not time to discuss this further.
